

ORDINANCE NO. 2021 - 18

BE IT ENACTED BY THE QUORUM COURT OF THE COUNTY OF SEVIER, STATE OF ARKANSAS, AN ORDINANCE TO BE ENTITLED:

AN APPROPRIATION ORDINANCE TO AMEND THE ANNUAL OPERATING BUDGET FOR 2021.


SECTION 1. AMENDMENT BY LINE ITEM TO ANNUAL BUDGET ADOPTED BY REFERENCE. An amendment by line item to the annual budget for calendar year 2021 for Sevier County, Arkansas are hereby adopted by reference. A copy of said amendment listing additions to or subtractions from specific line item amounts and wage and salary adjustments shall be filed in the office of the County Clerk and shall be available for inspection and copying by any person during normal office hours.

SECTION 2. MAXIMUM APPROPRIATED AMOUNTS AMENDED – ATTACHED

SECTION 3. SEVERABILITY. If any provision of this ordinance or the application thereof to any person or circumstance is held invalid, such invalidity shall not affect other provisions or applications of the ordinance which can be given effect without the invalid provisions or applications, and to this end, the provisions of this ordinance are declared to be severable.

SECTION 4. This ordinance shall be in force upon passage and approval. Payrates will be retroactive to October 4, 2021.

An Appropriation Ordinance to Amend the Annual Operating Budget for 2021 continued.

SECTION 2. MAXIMUM APPROPRIATED AMOUNTS AMENDED.

- A. There is hereby appropriated the additional amount of \$3476.00 to the County Treasurers Budget. \$2635.00 to line item 1001 Salaries Full Time; \$201.00 to line item 1006 Social Security Matching; \$588.00 to line item 1007 Retirement Matching; \$52.00 to line item 1010 Worker's Compensation. The budget committee gave elected official a rate adjustment for 2021.
- B. There is hereby appropriated the additional amount of \$6443.00 to the County Assessors Budget. \$5009 to line item 1001 Salaries Full Time; \$384.00 to line item 1006 Social Security Matching; \$952.00 to line item 1007 Retirement Matching; \$98.00 to line item 1010 Worker's Compensation. The budget committee gave elected official, and deputies a rate adjustment for 2021.
- C. There is hereby appropriated the additional amount of \$11215.00 to the County RSAT Budget. \$8977.00 to line item 1001 Salaries Full Time; \$687.00 to line item 1006 Social Security Matching; \$1375.00 to line item 1007 Retirement Matching; \$176.00 to line item 1010 Worker's Compensation. The budget committee gave RSAT employees a rate adjustment for 2021.
