## MINUTES SEVIER COUNTY QUORUM COURT MEETING 2:00 P.M., Monday, October, 9 2023

The Sevier County Quorum Court met at 2:00 P.M., Monday, October 9, 2023 in the Sevier County Courthouse Conference Room with County Judge Sandra Dunn presiding. The roll was called with the following Justices present: Michael Barnes, Kenneth Currence, Callie Efird, Scottie Morris, Walter Smith, Roxy Stephens, Angie Walker, Roger Whitmore, Greg Wright. Absent – None. Upon a motion by Roxy Stephens and second by Angie Walker, the Quorum Court voted to dispense with the reading of the minutes of the last meeting and to approve the minutes as emailed.

## Committee and Other Reports –

- 1. CEO Lori House was updated the Quorum Court on the September 2023 Operational Statistics.
- 2. Angie Walker gave an update on the Sevier County Airport Board. Mrs. Walker informed the Quorum the total sales for the month of August were 12,191 Avgas, and 33,973 Jet A for a total of 115 individual sales.
- 3. Gayle Gathright informed the Quorum that Southwest Ems had a total of 146 calls for the month of September with 71 taken to SCMC, 30 were transferred out from SCMC, 19 were taken from the scene to other facilities, 5 calls were flown out, 14 calls were refusals, and 7 calls with no patient found.
